- 5. Workshop Session Discussion of draft Greenleaf Air Ranch (GLAR) Development Agreement (DA) #3

Dan Hyer expressed intent to collect information and re-schedule the workshop. Discussion followed regarding availability. By consensus, Council decided to include the workshop as an agenda item at the o6 Nov 2025 Council Meeting.

Hethe Clark described the agreement, and first two amendments. Hethe outlined the three components in the proposed amendment #3:

- Extension of Agreement
- Periodic Reporting
- Mitigation Fund Contribution [HB389(2021)]

Hethe noted for Council that regarding HB389(2021) impact the Air Ranch is by nature a slow-moving product, and the property has already been annexed so there is no annexation loss of revenue from HB389.

Discussion followed, including status and marketing for the next Air Ranch phase. Phases 1 and 2 have been built, phase 4 is next, with construction drawings approved for phases 5 & 6. The Air Ranch is in a niche market which tends to follow the standard housing market, similar to recreational property and very susceptible to uncertainty concerns.

Discussion continued, including development of the SkyPark property outside Marsing, near Givens Hot Springs.

Ed Priddy expressed that development in the Air Ranch will move as it moves. He would like to see a phase complete every year to year and a half. Discussion followed regarding typical development processes.

General discussion followed. It was noted that mitigation may need more discussion, and that progress is important. Air Ranch design standards and process were described, along with layout for phases 7 & 8.
